Member Principal Clarinet

Manchester Camerata seek exceptional and flexible musicians capable of contributing to the future of this exciting chamber orchestra and it's exceptional wind section.

As a member of Manchester Camerata, you will perform an exciting range of repertoire to an incredibly high level locally, nationally and internationally and have the opportunity to be part of our Camerata in the Community work through creative music making.

In 2024 we offered approximately 41 days of orchestral work to principal clarinet with a projection of approximately 60 days of work for 2025. Camerata in the Community work would be additional to this. Please note depending on the concert programme and repertoire members are not always required for all concerts.

Due to the nature of the work that we do, an ability to play bass clarinet is a requirement of this role. Please state the clarinets you play on your CV.

Manchester Camerata has a commitment to diversity in its programming, staffing and community engagement, and actively seeks applications from the widest range of applicants.

After applying, applicants will be sent a survey link to help us gather equal opportunities data which will inform Manchester Camerata's organisational development regarding its Diversity and Inclusion policy and objectives.

- Candidates are required to submit an audio-visual recording of the first-round excerpts. Audio will be extracted from the video before being presented to the panel to ensure candidates remain anonymous. The video must be submitted as an mp4 file, recorded in one take, not edited in any way, and clearly labelled with your name and the position you are applying for. For help with this, please see attached supporting document.
- In addition, please send a copy of your CV and a one page covering letter (which doesn't repeat information from your CV and outlines why you are interested in

working with Manchester Camerata). Both files need to be saved as PDFs. Your CV and covering letter will only be shared with the panel if you advance to the second-round live auditions.

Successful candidates from the first-round video submission will proceed to the second-round live audition.

Second-Round Live Audition - in person:

- O PIECES Please prepare the first movement of Mozart Clarinet Concerto PLUS a second piece of your choice from any genre or style of music that you feel reflects your musical personality (the second piece can be any length, but the panel may stop you if required). You may also be asked to play some of the excerpts from the first round.
- O CHAMBER Please prepare the following pieces to be played with principal members of the orchestra:

- Please note that we are only able to accept applications from candidates who are eligible to live and work in the UK.
- The panel for both rounds will include section principals from the orchestra.
- You will receive an email from the Orchestra Personnel Manager with the outcome of your first-round video submission by Monday 14th April.

- A pianist will be provided for the second-round live audition and will be available for rehearsal 10 minutes before.
